#### Clean Water State Revolving Fund FY 2020

NM Environment Department is accepting applications for the Clean Water State Revolving Fund **from March 1—April 12, 2019**. Eligible projects include but are not limited to: publicly-owned wastewater treatment plants (WWTP), collection systems, decentralized wastewater systems, nonpoint source projects, and energy efficiency, water conservation or security projects at publicly owned WWTPs.

Eligible borrowers include: municipalities, counties, State Agencies, Water and Sanitation Districts, tribes and pueblos and Mutual Domestic Water Consumers Associations.
