#### Financial Considerations for Counties

- For reimbursement of your emergency expenditures, you must **document**, **document**, **document** your expenses, personnel time, etc.!!
- Pay attention to your county cash flow, liquidity of investments, bond obligations, pension funds
- Evaluate your investment structure
- Keep an eye on your balance sheets related to the decisions being made

**Federal Aid Packages -** Congress has passed a third coronavirus package late Wednesday.

Managers: If your county has passed a declaration of emergency, please email a copy to research@naco.org. Click MAPS to see which counties have declarations of emergency.

#### **Tips for Federal Aid**

- Counties: work with your state association, community partners, Health & Human Services, and Center for Disease Control to access funds from federal to state to local government
- Work with your health agencies on the cost and reimbursement for counties on Medicaid
- FEMA Disaster Relief Fund—<u>FEMA COVID-19</u> **Emergency Declaration Category B** Stay connected with your local FEMA office
- Health & Human Services and FEMA evaluating pandemic types of emergencies

### On Watch for Cybersecurity Attacks

- The Department of Health & Human Services was hacked
- Counties: work with employees and your IT to be on guard for fake emails, false information, especially while working remotely

#### President's coronavirus guidelines for America 15 Days to Slow The Spread

Listen to and follow directions of your **state and local** authorities

If you feel sick, stay home. Do not go to work. Contact your medical provider.

If your children are sick, keep them at home. Do not send them to school. Contact your medical provider.

If someone in your household has tested positive for the coronavirus, keep the entire household at home. Do not go to work or go to school. Contact your medical provider. **If you are an older person,** stay home, and away from other people.

If you are a person with a serious underlying health **condition that can put you at increased risk,** (lung, heart, or weak immune system) stay home, away from people.

## COVID-19 US Census 2020 Update

In the midst of dealing with this global pandemic, keeping state agencies going, and helping New Mexicans stay safe, the 2020 Census has not been cancelled and is still on the same timeframe with the exception of suspension of field operations until April 1, 2020.

# **Guidance on Modifying Outreach Activities**

Many of the previous outreach strategies relied on contacting people one on one and at large community events. Since most of these events have been cancelled and door to door outreach may seem less safe right now, we are asking all local CCCs to continue their push to get a complete and accurate count by pivoting strategies as necessary to still reach and motivate as many people as possible to fill out their Census form.
