

**All Special Legislative Session Bills Passed Signed by the Governor** The last bill to be signed by the Governor before the July 12 deadline was SB 8 Law Enforcement Body Cameras. This “body camera” bill gave us the most headaches with little communication or input and no appropriation. Twenty seven counties currently have or use body cameras. All Law Enforcement will have until **September 20, 2020**, when this law goes into effect, to develop policies and procedures for body cameras, send out RFP for body camera equipment, purchase a software management system and storage for the videos, amend budgets for the purchase, and train officers and staff on the use of body cameras. Peace officers who fail to comply with the policies and procedures required to be adopted shall be presumed to have acted in bad faith and shall be deemed liable for the independent tort of negligent spoliation of evidence or the independent tort of intentional spoliation of evidence. Needless to say, the NMC legislative team will work on changes to this bill during the interim before the next 60-day legislative session. ### Ransomware 101 Hackers

- **WannaCry**-most prevalent ransomware
- **LockerGaga**-arrives via compromised credentials; modifies the passwords of infected system users; prevents reboot
- **RobbinHood**-arrives via remote desktops or Trojans and encrypts each file
- **MegaCortex**-targets corporate networks; uses Windows domain controllers
- **MedusaLocker**-accesses mapped network drives, erases Shadow Volume copies, removes backups, and disables Windows Automatic Startup repair; relaunches every half hour
- **Infection vectors use**-Email, Drive-by download, Remote Desktop Protocol, and Free software downloads
