Legislative Immunity from suit

- Government officials are immune for all actions taken "in the sphere of legitimate legislative activity" (*Bogan v. Scott-Harris*, 523 U.S. 44, 49 (1998)).
- A legislative act generally involves policymaking rather than mere administrative application of existing policies.



Legislative Immunity from suit

- A decision is more likely administrative if the facts used to make a decision are *specific* rather than *general*.
- If the decision affects specific individuals rather than the general population, it is more apt to be administrative in nature. (*Smith v. Lomax*, 45 F.3d 402 (11th Cir. 1995)



Legislative Immunity from suit Potential or alleged motives are not relevant when determining whether an act is legislative (*State Emps. Bargaining Agent Coal. v. Rowland*, 494 F.3d 71, 90 (2d Cir. 2007)).

Motives of supervisors are always relevant in employment suits.

**Despite your good intentions, if** you involve yourself in individual personnel matters you will taint the process and create potential civil rights claims against you and your county.




Passing a note to County Manager requesting an employee be disciplined =supervisor=no legislative immunity =

- putting colleagues into categories of "close-up" or "camera off,"



Snipes about an older worker's ability to use technology demonstrates age bias and adding a LOL or a happy face to the comment won't excuse the behavior in court.







#### **Camera Off?**




### Multitasking
