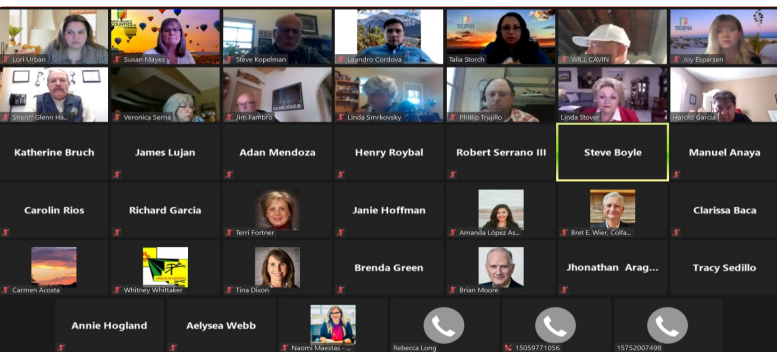
- Grants of \$1,500 to \$20,000 awarded

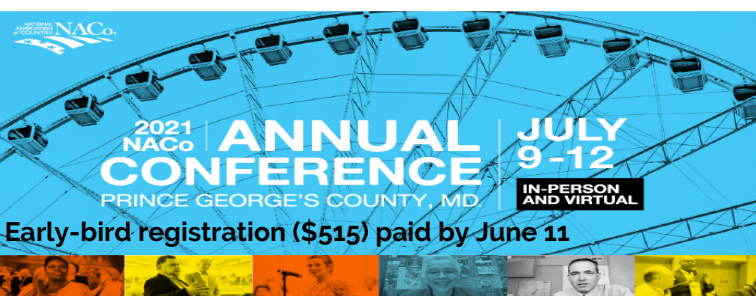
