Guest Trainers

It is not uncommon for guest trainers to teach portions of an OSHA 30- hour training. Guest trainers are required to meet OSHA qualifications on the topic covered.

Student Achievement

Upon completion of the course, students will receive a Department of Labor OSHA 30-hour card in the mail within 6-8 weeks.

Attendance

Students are expected to arrive on time ready to learn. Student attendance is strictly monitored. Students are expected to attend all training modules and cannot leave the class to take personal or professional phone calls. If a student misses more than 20 minutes from any module they will no longer have the ability to obtain receive an OSHA 30-hour card.

Breaks and Meals

NMC will also provide lunch for all (3) training days. Water, soda and light snacks will be provided. Breaks will be given at a minimum every 2 hours.

Class Style

The class will include workshops, case studies, and demonstrations requiring students to participate. Videos will be played during the training, however videos will represent less than 20% of the class time.

Student Verification

Students will be required to bring a photo ID to check in to class.

Training Language

This class will be given in English. All materials and tests will be in English.

Class Size

OSHA 30-hour classes are limited to 40 students with a class minimum of 3 students

Class Materials

Each student will receive a binder with study materials, and future reference materials. Students should bring pens, pencils, highlighters, and sticky notes as these items will not be supplied.

Test and Quizzes

Students are required to take a tests and or quizzes to confirm comprehension.

Training Fee

There are no fees associated with this training if your county purchases workers compensation coverage through the NMCI pool.

County Members who do not purchase their workers compensation from the pool will be asked to pay \$265 per person to cover the materials, food, and supplies associated with this training.

Students are expected to comply with all COVID-19 safe practices established by San Juan County in accordance with NMDOH and CDC recommendations and requirements.
