Fun Facts About the Fourth of July

- The official congressional vote on the Declaration of Independence happened two days before the "Declaration" was published in papers on July 4, 1776
- The designer of the 50-star flag was a 16 year old male from Ohio; he designed a new flag using the old 48 star flag, earning a B-minus to which he challenged by sending it to DC to be considered by President Eisenhower; once the flag was selected, his grade was changed to an A, and his design became the official flag in 1960
- Americans are expected to eat 150 million hot dogs over the July 4th holiday
- Only two men, Charles Thompson and John Hancock, signed the Declaration of Independence on July 4, 1776; the other 54 delegates signed over the course of the next month
- The average age of signers was 45 years old; the youngest was 26 years old; Ben Franklin was 70
- Americans spend more than \$1 billion on fireworks each year
- July 4th was not deemed a federal holiday until 1870, nearly 100 years after the nation was founded NMC will be closed on Monday, July 5th to observe the holiday. Stay safe!
