
National Fire Capacity (State Fire Assistance)

Rural Fire Capacity (Volunteer Fire Assistance)

Non-Federal Lands Hazardous Fuels

- Project Amount up to \$300,000
- No Match Requirement
- Projects must be adjacent to National Forests and coordinated with fuels work conducted on National Forests in the past 5 years or planed in the next 5 years.
- Request for Applications beginning in January
- Proposals due in April

National Fire Capacity

(State Fire Assistance)

- 1:1 Match
- Reimbursement Grant
- Can be used for Training, Equipment, Planning (CWPP), Prevention Efforts and Hazardous Fuels Work (annual competitive western-WUI grants)
- Request for Applications beginning in January
- Proposals due in April

Rural Fire Capacity Volunteer Fire Assistance Grant

- Reimbursement Forestry Division reimburses fire department once procurement is completed by fire department.
- Fire Department must provide 10% Local Government Match
- Fire Department must meet the following requirements:
 - Is recognized as a fire department by the laws of the State
 - Provides service **primarily** to a community or city with a population of less than 10,000
 - Firefighting personnel is 80 percent or more volunteer
- Can be used to purchase Personal Protective Equipment and hand tools, used to equip FEPP engines and radios.
- Grant can be used for training activities and Education/Prevention.
- Can be used to fund a Wildland Fire Coordinator part time position.
- Can be used to fund dry hydrants or other special projects, other than capital improvements.

Rural Fire Capacity Volunteer Fire Assistance Grant Application

- FY22 VFA Grant Application and packet has been revised to address updated reporting criteria and better assist applicants in the process.
 - Applicant encouraged to reference their Community Wildfire Protection Plan.
 - Applicant encouraged to reference the local government

Joint Powers Agreement (JPA) or Memorandum of Agreement(MOA).

- Communities At Risk (CARS) .
- Emphasis on well written Project Plan Narrative and Budget Proposal.
- Applicants who <u>may not</u> fall into "priority" categories will be scored using other considerations.
- Forestry Division's goal is to build wildland fire response capacity in New Mexico's VFD's.


VFA APPLICATION TIMELINE

- Applications Available: October 15, 2021
- Applications Due Back to Forestry Division: COB November 15, 2021
- Applications reviewed in late November early December.
- Because of Holidays the review period may extend to January 2022.
- Reviewers submit scored applications.
- Award committee convenes and selections made.
- Pre award applicants sent for Federal Compliance and State Audit reviews.
- Notification letters sent to applicants.
- Grant Award Agreements (GAA's) finalized and signed by local government and Forestry Division.
- Notice to Proceed packet sent to awardee to begin purchasing process.

Corrales Fire Department Sandoval County

With funding provided by VFA Grants, through the US Forest Service and New Mexico EMNRD – Forestry Division, Corrales FD has been able to update their wildland Personal Protective Equipment, equipment for brush trucks such as hoses, appliances and hand tools, and Float Pumps that work well in the nearby river and the area's irrigation ditches.
