USDA Rural eConnectivity Program—ReConnect \$1.15 billion in loans and grants to expand the availability of broadband in rural areas with <100 Mbps downstream/20 Mbps upstream

- Provide 100 Mbps symmetrical broadband service to all locations (<25/3 Mbps score higher)
- Funds may be used for construction, reconstruction, and acquisition of broadband facilities and not for services (public-private partnerships must have a lead applicant primarily responsible)

Up to 40% of total requested funding for acquiring existing facilities

- Applicant must own the facilities and cannot use funds to lease dark fiber for network
- Up to 5% of requested funds may be used for application costs
- 5-year build out requirement
- Project must be technically feasible
- All project costs must be able to be fully funded or accounted for
- Facilities funded with ReConnect funds will provide the broadband service proposed in the application for the composite economic life of the facilities
