Roundhouse Guidelines Summarized

Per Legislative Council Policy No. 26, beginning on December 6, 2021, all firearms are prohibited in the State Capitol with limited exceptions. Adequate proof of being fully vaccinated against COVID-19 required unless an individual qualifies for exemption and proof of negative test within the previous 48 hours.
