2023 REGULAR SESSION DATES

01/03/2023 -- 01/13/2023 -- Legislation may be prefiled
01/17/2023 -- Opening day (noon)
02/16/2023 -- Deadline for bill introductions
03/18/2023 -- Session ends (noon)
04/07/2023 -- Legislation not acted upon by governor is pocket vetoed
06/16/2023 -- Effective date of legislation not a general appropriation bill or a bill carrying an emergency clause or other specified date.

NACo: Notice of Funding Opportunity

There are **15 funding opportunities** open now through the Bipartisan Infrastructure Law where counties or local public agencies are eligible to apply. These opportunities total roughly \$6 billion and range from funding for bridge projects to broadband deployment to marine debris removal to improving equity in infrastructure.
