We invite you to submit a proposal that focuses on our theme and share experiences and lessons learned that will help others who share similar challenges in New Mexico's rural and urban wildland interface. Presentations should be non-judgmental and solution oriented.

Audience

Fire service volunteers and professionals, non-profit conservation groups engaged in fire adaptation, and federal, state, and local government representatives.

Types of Presentations

Mini Talk (up to 15-minutes)

Short presentations that tell stories, share challenges, and show how practitioners are rising to the challenge. Talks could be prerecorded videos and/or can be part of a small topical group panel.

Peer Learning Session (30-minutes)

❖ Group/General Presentation (45 minutes - 1 hour) Broader topics such as research findings and large-scale issues.

- Maximum 100-word description of presentation/video
- Speaker biography (1-3 sentences)
- Audio/visual needs (or other needs)
