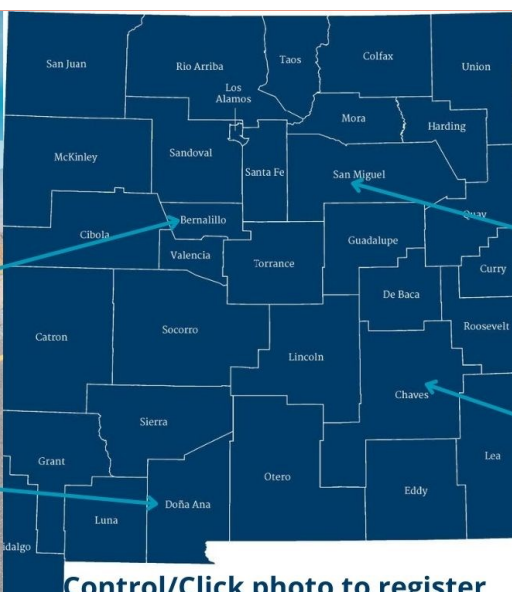

[New Mexico Environment Department \\$800k Available for Recycling, Illegal Dumpsite, and Scrap Tire Cleanup](#)

RAID grants available to counties, pueblos, nations, tribes, solid waste authorities, cooperative associations, and land grant communities for FY 2024. Two-thirds awarded for scrap tire management/abatement projects, and one-third for recycling projects/illegal dumpsite abatement. Matching funds/in-kind contributions are not required but are encouraged. Land grant communities are encouraged to partner with the county in which they are located. Find out more [HERE](#).
