


The Supreme Court recently issued decisions on a number of cases with direct implications for county governments, covering topics like employment law and WOTUS.

The National Telecommunications & Information Administration (NTIA) has announced state funding allocations for the \$42 billion Broadband Equity, Access, and Deployment (BEAD) Program. This initiative is set to bring high-speed, affordable internet access to county residents in unserved and underserved areas, bridging the digital divide.

The Economic Development Administration (EDA) has <u>announced a \$200 million pilot for</u> the Recompete Program, with at least 20 plans receiving grants of \$6-12 million. This **investment** is intended to catalyze economic recovery and growth, targeting economically distressed communities with high
